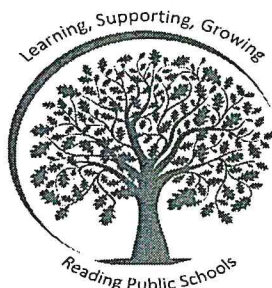

# Reading Public Schools

Dear Parents,

We are once again able to offer a parent paid bus. If you are interested, the parent paid bus will transport students to school in the morning and home at the close of school for **\$450.00** per student with no family cap. Unfortunately, we are not able to offer a one-way ticket for half price. Reading Public Schools offers financial assistance for those eligible for free and reduced meal benefits. Currently, we provide bussing as mandated by state law for students in grade K – 6 that live 2 or more miles away from their school. In the 2018-19 school year, we will be able to offer parent paid bussing to non-mandated riders (students who live less than 2 miles from their home school and for some students grades 7 – 12) along the established routes at **Killam, Coolidge, Parker and Reading Memorial High School**. For this option to continue there will have to be enough paid ridership to cover the cost of the bus.

Passes are **non-refundable** and **non-transferable**. Payments will be accepted by mail or may be dropped off at the Superintendent's office. We strongly urge you to procure your child's spot as soon as possible as they are issued on a first come-first serve basis. No passes can be issued until paid in full. **Passes will be available the week of August 20<sup>th</sup>**. If you are interested in using our electronic payment option, eSchool, please contact Linda Engelson.

Any interested parent or guardian is asked to complete the attached form and drop it off or mail it, along with a check made payable to the "**Town of Reading**" to Reading Public Schools, 82 Oakland Road, Reading, MA 01867. Payment must be received by **July 20, 2018**
